Anything that mixes with rain becomes stormwater pollution!

For that reason, it is important to dispose of HHW properly.

Dumping common household chemicals down storm drains, pouring them on the ground, or putting them in the trash can dramatically affect the health of our local waterways.

Runoff from rain, snow melt and sprinklers washes chemicals on the ground into streams, rivers and lakes untreated. This can cause contamination of our drinking water and harm recreation areas.



One quart of oil can affect an area the size of three football fields and one gallon of oil can pollute 250,000 gallons of water!

PCSing? Only two options for HHW on JBER: Give it to someone who can use it or Dispose of it at ARL. AD Army cardholders can drop off 40 pounds for free (up to 200 pounds per calendar month) at the ARL. Extra weight per day or month will be charged regular ARL fees.

If found illegally dumping HHW, including leaving HHW at the JBER Thrift Stores, you may be held liable.

What is Household Hazardous Waste (HHW)?

Leftover household products that contain **corrosive**, **toxic**, **flammable**, or **reactive** ingredients are considered HHW.




These materials can include:

Automotive products (antifreeze, fluids, motor oil, oil filters, gasoline, etc.)

Batteries (home and vehicle)





Household cleaners (ammonia, drain cleaner, rust remover, etc.)

Paint products (oil-based paint, latex paint, spray paint, caulk, wood stain, etc.)

Garden chemicals (pesticides, herbicides, fertilizers, insecticides)

Reduction at Home

Check the label before you buy. If you see a cautionary notice, this material will become HHW if not used properly.

Use the product as the manufacturer instructs. Companies test their products to comply with federal regulations. Directions must be followed to get maximum benefit from the products without compromising safety.

Buy only what you need. Surprisingly, some products cost more to dispose than they do to purchase. Using forethought when purchasing these products may save your community the cost of disposing of them as HHW.

Store products safely. Children, pets, and others may injure themselves when products are not safely stored. Make sure potential HHW is stored out of harm's way.

Pharmaceuticals and Medication

Do not flush or wash down the drain!
Anchorage Water and Wastewater Utility's wastewater treatment facilities are not designed to remove pharmaceuticals and medications.
