## **JBER Motorcycle Training Instructions**

Once your motorcycle training request is approved by the JBER Occupational Safety Office, you may proceed with scheduling the requested course with the contractor. Motorcycle training is contracted through Motorcycle Times Inc. (MTI) at the following locations:

## Approved riders must call before visiting the dealership to register for the class they are approved to attend.

Riders have <u>10 calendar days</u> to deliver the approved request form and schedule training. At that point, riders will receive further instructions and class materials from the contractor. Failure to comply will result in the voucher becoming invalid. Booking classes at both locations at the same time to obtain a preferential slot is not authorized by the contractor and may result in the rider reimbursing the contractor or government.

Cancellation and rescheduling requests must to be given to MTI within <u>48 hours</u> prior to the course start date, or the rider will be responsible for the cost of the training per the Commander's Policy on Motorcycle Safety (JBER-57).

Riders must provide their own personal protective equipment (PPE) for training. Riders are highly encouraged to use gear that incorporates fluorescent colors and retro-reflective material. In accordance with directives, riders must have the following PPE:

-Helmet IAW Directives -Full Fingered Gloves or Mittens -Long Sleeved Shirt or Jacket -Eye Protection (ANSI Z87.1 Approved) -Over the Ankle Sturdy Footwear -Long Pants
